# Salary :

HK\$ 39,350 per month (Note (1))

## **Entry Requirements :**

- (a) (i) have a Master degree in Public Health, Epidemiology and Biostatistics, Environmental Health or Environmental Science from a Hong Kong university, or equivalent; or
  - (ii) have a postgraduate diploma in Public Health, Epidemiology and Biostatistics, Environmental Health or Environmental Science from a Hong Kong university, or equivalent, with 2 years' relevant full time post qualification working experience.
- (b) in addition to requirement (a), another 2 years of relevant full time post qualification working experience in conducting environmental health/ epidemiology related research studies, environmental health risk assessment, risk communication, data base management and data analysis is preferred (Note (1));
- (c) Meet the Language Proficiency Requirement :
  - (i) Level 3 or above in Chinese Language and English Language in the Hong Kong Certificate of Education Examination (HKCEE) or Hong Kong Diploma of Secondary Education Examination (HKDSEE) or equivalent (Note (2)); or
  - (ii) have (1) Chinese Language and Culture or Chinese Language and Literature and (2) Use of English at "Grade E" or above in the Hong Kong Advanced Level Examination (HKALE), or equivalent; and
- (d) be able to speak fluent Cantonese and English.

## [Remark: Candidates may be invited to attend a written test.]

Notes:

- (1) Candidate unable to comply with Entry Requirement (b) may also apply but may enter at a lower salary.
- (2) For appointment purpose, 'Grade C' in Chinese Language and English Language (Syllabus B) in the HKCEE before 2007 are accepted administratively as comparable to "Level 3" in Chinese Language and English Language in the 2007 HKCEE and henceforth.

## Duties

- (a) Provide professional input on environmental health issues (including physical, chemical and biological hazards);
- (b) Monitor, collate, review and appraise scientific and medical literature/evidence on various environmental health issues;
- (c) Provide comments on environmental health issues in various studies and projects;
- (d) Carry out environmental health risk assessments / studies; and
- (e) Provide statistical support.

# [Remark: May be required to work shift and irregular hours.]

**Terms of Appointment** : Successful candidates will be appointed on non-civil service contract terms up to one year. Renewal of contract will be subject to the service need of the Department and the performance of the candidate.

**Fringe Benefits :** Rest days, statutory holidays (or substituted holidays), 14 days' paid annual leave, maternity/ paternity leave and sickness allowance, where appropriate, will be granted in line with the Employment Ordinance.

## **General Notes :**

- (a) Candidates must be permanent residents of the Hong Kong Special Administrative Region at the time of appointment unless specified otherwise.
- (b) As an Equal Opportunities Employer, the Government is committed to eliminating discrimination in employment. The vacancy advertised is open to all applicants meeting the basic entry requirement irrespective of their disability, sex, marital status, pregnancy, age, family status, sexual orientation and race.
- (c) Non-civil service vacancies are **not** posts on the civil service establishment. Candidates appointed are **not** on civil service terms of appointment and conditions of service. Candidates appointed are not civil servants and will **not** be eligible for posting, promotion or transfer to any posts in the Civil Service.
- (d) The entry pay, terms of appointment and conditions of service to be offered are subject to the provisions prevailing at the time the offer of appointment is made.
- (e) Where a large number of candidates meet the specified entry requirements, the recruiting department may devise shortlisting criteria to select the better qualified candidates for further processing. In these circumstances, only shortlisted candidates will be invited to attend

recruitment examination and/or interview.

- (f) It is Government policy to place people with a disability in appropriate jobs wherever possible. If a disabled candidate meets the entry requirements, he/she will be invited to attend the selection interview/written examination without being subject to further shortlisting.
- (g) Holders of academic qualifications other than those obtained from Hong Kong institutions/Hong Kong Examinations and Assessment Authority may also apply but their qualifications will be subject to assessments on equivalence with the required entry qualifications. 
Application Forms [G.F. 340 (Rev. 3/2013)] are obtainable from any Home Affairs Enquiry Centre of District Offices, Home Affairs Department or any Job Centre of the Employment Services Division, Labour Department. The said form can also be downloaded from the Civil Service Bureau's website at <u>http://www.csb.gov.hk</u>. On-line application can also be made through the same website.

The application period for the post of Research Officer (Public Health) is from 28 April 2017 to 18 May 2017. <u>Applicants should state in details in the application forms their requisite academic qualifications and requisite post-qualification working experience</u>. They must also attach copies of their official transcripts of studies and certificates, documentary proof of their requisite post-qualification working experience, and curriculum vitae on the working experience to their application forms. Completed application forms should reach the enquiry address indicated on or before the closing date for application with the envelope clearly marked "Application for the post of **Research Officer (Public Health)**". Applications not made in the prescribed form, submitted by fax or email, or which are incomplete or late submission will not be considered.

For online applicants, copies of all relevant documents must be submitted to the enquiry address indicated within one week after closing date for application. They should quote the online application number on the envelope and every page of the copies of the documents. Please do not send originals of transcripts/ certificates.

Applicants should ensure that the correct address is clearly printed or written on the envelope and sufficient postage is affixed before posting so as to avoid unsuccessful delivery of application. Any underpaid mail items will be returned or disposed of by the Hongkong Post.

Candidates who are selected for interview and/ or written test will normally receive an invitation in about six to eight weeks from the closing date for application. #### 入職條件:

- (a) (i) 持有香港任何一所大學頒授的公共衞生、流行病學與生物統計學、環境 衞生或環境科學碩士學位,或同等學歷;或
  - (ii)持有香港任何一所大學頒授的公共衞生、流行病學與生物統計學、環境 衞生或環境科學深造文憑,或同等學歷,並在取得有關學歷後,具備兩 年相關全職工作經驗。
- (b) 除(a)項條件外,如在取得有關學歷後,在進行與環境衞生/流行病學有關的研究、環境衞生風險評估、風險傳達、數據庫管理及數據分析方面,具備另外兩年相關全職工作經驗,可獲優先考慮(註(1));
- (c) 符合語文能力要求:
  - (i) 在香港中學會考或香港中學文憑考試中國語文科及英國語文科考獲第3 級或以上成績,或具備同等成績(註(2));或
  - (ii)在香港高級程度會考中,在(1)中國語文及文化、中國語言文學或中國語 文科,以及(2)英語運用科考獲 E 級或以上成績,或具備同等成績;以及
